PUT CHILDREN AND YOUNG PEOPLE AT THE HEART OF GOVERNMENT SPENDING.

To the Prime Minister and Chancellor of the Exchequer

We are writing to you because there is compelling evidence that the services and support that children and young people rely on are at breaking point. We believe this is because children and young people are being ignored in the Government's spending plans.

- Ninety children are being taken into care every day – this is a record high<sup>i</sup>;
- Less than a third of children and young people with a diagnosable mental health problem will get access to NHS funded treatment this year<sup>ii</sup>;
- Only three in a hundred families of disabled children think the health and care services available to their children are adequate<sup>iii</sup>;
- Almost three-quarters of school leaders expect they will be unable to balance their budgets in the next financial year<sup>iv</sup>;
- The number of children with special educational needs who are awaiting provision has more than doubled since 2010<sup>v</sup>;
- Up to 3 million children are at risk of going hungry during school holidays<sup>vi</sup>.

We have come together at this crucial time to urge you to put children and young people at the heart of government spending.

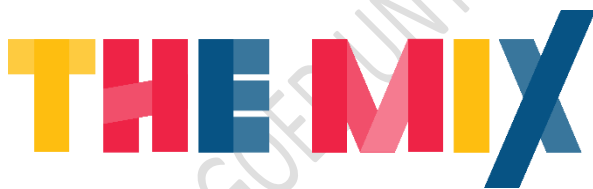
